Distribution

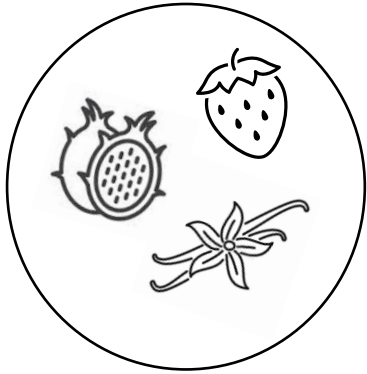
We handle all distributions with delivery follow-ups from point A to point B with the support of the distribution center.

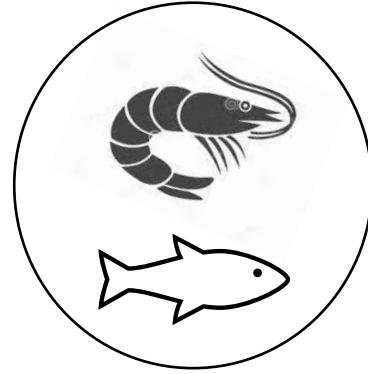

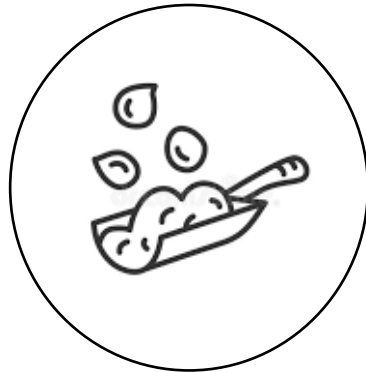
Seafood



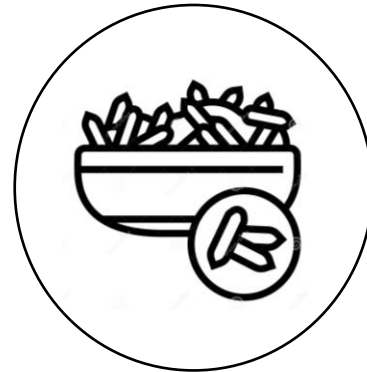
Dry fruits
